ABSTRACT

CHAPTER ONE

INTRODUCTION

1.1 Background to the study

According to Abari (1998) discipline is a state of affairs in which established rules, regulations and law are willingly and conscientiously obeyed with by members to achieve and maintain order in society.

This is similar to the ideas to Adeshina (1990) who opined that, discipline implies control restrains respect for self and respect for others. It calls for sacrifice perseverance, tolerance and recognition of human dignity. Odeku (2024) said that indiscipline is behaviour that is not acceptable in school at home and in society. Immoral action like telling lies, stealing, fighting and all forms of behaviour that are not welcome in society. Lack of indiscipline is the root of indiscipline, the common forms of indiscipline among the students are examination malpractices, staying outside the school compound while other students are in the class, getting out of the school through fence fighting, stealing vandalizing school rules or orders, joining cults, beating up teachers

extorting money from junior students or beating up the junior for no solid reason, others are telling lies against other students and teachers playing and disturbing other students or other classes who are busy with their study drinking and smoking of beer and drug in the school compound or outside the school gate by students addressing the seniors and the teachers rudely, and playing no attention in class

Studies Laja (1998) assent that for the training of students in acquisition of various traits and character in order to prepare them for their future livelihood, that is the need to ensure the existence of clubs and societies in school. Apart from inculcating characters, training the students, involvement of students in activities can make valuable contributions, to the development of schools and it exposure to outside world. attitude of social behaviour like bribery and corruption, greediness, dishonest, excessive materialism, Distruction, Enthniocentricism, Lack of respect for elders and those in authority, Extravagance, examination malpractices, Smuggling, Drugs Trafficking and Disregard for life on the road on our own constitute the concept of indiscipline (Olatunj) 2002. These are so rampant in the society today that we cannot take of any meaningful development in the society

2.2.1 Purpose of Islamic Education

Discipline concern loyalty, obedience, fidelity, surveillances, habit formation, mental and moral training with system in the scope of education, Islamic education is extremely important for varsity students even babies before the globe of education. children must be tell Islamic education so when they renter the planet of education, they are going to get accustomed to it and they will have to add and implement it daily in life. Discipline is one of the most significant personality traits in everyone's life it refers to a set of rule and regulations which are to be strictly followed when undergoing any task of activity it is a

way of been honest, hardworking, motivated, encouraged while doing any work and the role of discipline in our life is to set orderliness, efficiency, punctuality, organisation and focus on our tasks.

Islam encourages Muslim to display responsible behaviour in life. it disallows drinking of alcohol, gambling and other vices which make people move towards indiscipline lancity. the regulation of man's conduct within one system of life is one of the most important reason of success and stability, and the absence of this regulation is one of the greatest crisis a man suffer from in his life. This happens when man is left without guidance from Allah (S.W.T) and under this circumstance, man's life become miserable on this earth and thereafter by being discipline Muslims make sure that everything that passed is worth spent, and they are left with regrets in there. As Allah state in the Qur'an that "those who waste their time is living their life in vain. (27:28)Surat An-Naml.

Form Islamic perspective indiscipline is seen as a form of disobedience to God and His Command. It is viewed as a moral and spiritual failing that have negative consequences for both the individual and society as a whole Islam emphasize the importance of self control, and self restraint, as these are seen as essential quality for living a pious and virtuous life. According to Islamic teachings, indiscipline is a form of sin that can lead to moral and spiritual corruption, and can ultimately destroy the individual and society.

Source from Qur'an Allah says " o you who believe fear Allah and with those who are true (in word and deed)" (9:119) .in another verse, Allah

Says: " and let those who oppose the messenger's commandment beware, lost some fitnah (trail, affliction, e.t.c.) befall them or a painful torment be inflicted on them " (24:63).

Source from Hadith the prophet Muhammad (peace be upon him) said "because of greed for it is more demanding than hunger" .He also said said "whosoever controls his anger at the time when he has the means to act upon it, Allah will fill his heart with contentment on the day of resurrection"

2.3 Indiscipline among Students at College of Education Ilorin

In institutions as in some other societies, there has been more materials and less spiritualism on the youth / Students aspiration for instance. In many Nigeria higher institutions societies existed and tended to undermine discipline lack of will inability to face challenges of life positively.

There has been blatant extravagance and luxury since independence which has had a very bad effect on our young people (students) because of the eir lack of responsibility and discipline they perceived themselves as adults they do so by stealing up against the authorities in higher learning. They also engages in drinking and seducing young girls, wearing insensitive clothes in the web town or school premises, sensitivity to incentious impulses, passiveness over female and sexual jealousy, the desire for variety of sex life because the order of the day. Morally deficiency action like cheating, telling lies/lias stealing, smuggling and other actions that are harmful to other plans are destructive to society also constitute indiscipline acts among the students and youths in general

2.4 Causes of Indiscipline in the College

2.4.1 The Home factor

We all begin our family life in our family. Every family has its own home. The home is the first place where we first develop our character As a child grows up he/ she want to do many things

However, discord and disharmony parental mental disorder, criminality, large family size and overcrowding in the home, admission of the child into care of the local authority and low occupational status were all associated with indiscipline of the students at home (Dele, 2003)

Today in Nigeria it seems that the average home as a unit no more alive to its unique responsibility.

Many parents and guardians have abandoned the training of the children and wards to the pursuit of economic well being many parents and guardians have neglected and jettisoned the training and upbringing of their words and children to house-helps, nannies surrogate mother, day care center and mother in laws who are now responsible for training and bringing up children.

The serious lapses in the training of children point to the façf that the home has failed to lay any sound and concrete foundation for child formal and lifelong education. It should be noted that the indiscipline among the children in the house causes the lack of responsibilities and seriousness in the higher learning i.e. (college). There is a very little the school can do to produce a well discipline students for the saying goes that "Charity begins at home"

2.4.2 The School Factor

Indiscipline in a school is brought about by combinations of various factors. External and Internal, this include government policy, the altitude of the community to Education of the children (youths) the quality of the staff in the school, the way the students in a school is administered and physical facilities available to a school. None of these factors can be left out if Indiscipline must be eradicated in the school.

Thus teachers today are indiscipline, they teach in the examination hall, teach children to lie and falsify results for example, there is a school where the sch6head gives classes mixed registered or an attendance to class prefects to mark and compute (Dele Giwa 2003). Instead of teacher attending classes they ask students to mark them present when they were actually absent. A teacher who is always in school on time, where work is well prepared and whose Mateo are always ready and in order is going valuable training to the children. The history of indiscipline in our higher learning could also be traced to eradication of prayer and spiritual activities. One who said there is no God deceives himself and the fear God they said is the beginning of wisdom, devil finds job for idle hands. Most students and academic staffs are no more involved in co-curricular activities, hence, they now have time for mischief making and gossiping. Students too now engage in riot making. Facilities like a well laid out school farm practice agricultural science, a well equipped library, football field, Court for table tennis, indoor games of all sorts are no more in vogues, hence students cannot be kept busy but engage in indiscipline activities of various sort.

2.4.3 The Societal Factors

There is moral decadence today in our society as a result of corrupt society where the school exist upon which they reflect. According to Dele Giwa (2003) speak on the xviii

societal factor produces debauched and prostitutes, build hostels, lodging and brothel in the name of esteem civilization.

Our native culture has been westernized, divorce, separation and hunting are now the order of the day which produces Area boys, Vagabond, Pickpockets, Burglar and traint from schools. A thorough insight to the happening in the Muslim world has revealed the tendency of every ageing of western world been exactest civilization and culture in Muslim youth in the we campus without any regards to its ultimate negative effect.

A good Muslim must not smoke drink alcohol womanise or engage in any immoral acts. However due to the influence of western culture some Muslim are caught hands deep in moral degradation.

2.5. THE EFFECTS OF INDISCIPLINE ON THE ACADEMIC PERFORMANCE OF STUDENTS

The adverse effect of indiscipline on the academic performance of students cannot be over emphasized. Whosoever lacks discipline cannot attain any academic discipline, lack of concentration and seriousness on the part of students is contributing to the woeful performance in their academic pursuit.

This urgly happening has made attainment of academic excellence a ruse. Indiscipline will however adversely affect the growth of the school. The tone of the school will then change from good to bad as student might even be challenging the authority of the trainer, teacher

or lecturer in the academic as well as violating the interest of the school by not obeying the rules and regulations of the school.

This will then lead to the desalination of so much cherish academic peaceful atmosphere. The effect of indiscipline in the society is that the desireable altitude like honesty, faithfulness, hardworking as well as mutual trust have been eroded the effects on the society are anti social behaviour like bribery and corruption greediness, hisnosty, excessive materialism distrust ethnocentrism, la k of respect for elders and those in authority, absenteeism and lateness to work, selfishness, extravagance, cheating in examination, smuggling drug trafficking and desregard for life on our roads (Olatunji, 2003).

2.5.1 The Home Contribution

The home is regarded as an energy of education according to Dele Giwa (2000). It was viewed as the place where a child receive his first information possible before the e relevant education, his formal training. The home is the initial foundation upon which other agencies of education including the school later built on the foundation of a child. Intellectual moral and spiritual growth and development is laid in the home where parents, sibling and other significant adult attempt to develop the children initial tendencies that is the effective, cognitive and psychomotor skills of the child

2.5.2 The School Contribution

Discipline in a school is brought about by a combination of various factors external and internal such as government policy the attitude of the community to education of the youth/students, the quality of staff in the school, the way the students in a school are administered and physical facilities a available to a school. None of these factors can be left out if discipline is to be attained in a school. Discipline of student now adays required more understanding, sympathy and care that it used to be twenty or more years ago. This is because people change with time students of twenty years ago are different in many ways with respects. Motivation economic condition, social environment and maturity (Dele, 2005).

2.5.3 The Societal Factor

For peace and harmony, members of a social group must adhere to the norms of that group. The individuals making up a social group must exhibit such behaviour that will guarantee the survival of the society. In a nutshell people have to be disciplined so as to live peacefully with one another.

Discipline thus is define as the act of training the mind and character to develop self control habit right social conduct and right attitude to life is very essential for survival of any society. Thus for a society to survive in the modern world member must be discipline (Olatunji, 2003).

Essentially, a disciplined society must possess the following attribute or make sacrifices and contribution towards solving the Societal crises them when they arise. These include value such as general, personal and group values which embrace political, social economic and cultural aspect the society approved ones which the student and youth must

cherish include justice, faithfulness, obedience to law, tolerance, patriotism, love, discipline morality, frugality, respect for elders and seniors respect for individual property, accountability, responsibility and consideration for others. To move society forward, the above stated aspects of national ethnics must be imbibed and manifested by every member of the society.

2.5.2 Islamic Solutions To The Acts Of Indiscipline

Islam is not just a religion but total submission to the will of Almighty Allah it is also a total way of life. Islam therefore prefers solution to the act of indiscipline in a more dignified ways.

2.5.3 Obedience To Constituted Authority

The glorious Quran final Revelation. Holy Book of Almighty Allah, adminishes the Muslims in a very clear term that: Q4.59

"o you who believe, obey Allah and obey the Apostle, and those charged with authority among you, if you differs in anything among yourselves refer it to God and his Apostle, if you do believe in Allah and the last day that is the best and most suitable for final determination This command from Allah to his creatures. He request them to follow his will and instruction of his Apostle; a Muslim should also follow the order and regulation of the prevailing authority of his country, state and districts. Are a given time a Muslim should bear in mind that the ultimate authority belong to God, Men of Gid derive their country's authority from him. To obey the lawful government here is compulsory

otherwise, there will be a state of lawlessness. Those will be no order of discipline. In the web school is a must as a student to follow the rules and regulations of the school authority i.e

Exam malpractice wearing improper cloth, politics issue should not cause misserable fight and damaging of school items. This is against the Islamic religion which is a religion that preaches orderliness, discipline as well as organization where there is a sharp division between law and morality between secular and religion affairs. A school boy or girl is expected to respect and obey the school authority whatever confuses it should be left to Almighty Allah for final judgement (Salaudeen 2000)

Truthfulness means not only that we should do our duty honesty and live our only for ourselves but also for all those who we are obliged for our health, wealth, knowledge and above all to our community and nation (Abdul, 1995)

When say a certain quality is good, there is no doubt that it is beneficial when we says that a certain quality is bad, there is no doubt that is harmful. The definition of good and bad conduct contains Allah wisdom which may or may not be able to appreciate with our limited human vision, it was through constant truthfulness and honest behaviour that the prophet Muhammad as a young man was given the honour of the name Al-Amin (The trustworthy. (B. Aisha lemu 1990).

2.5.5 JUSTICE

The word justice refers to the quality of being just fair Judgment involved in the e determination of rights or wrong and the assignment of rewards or punishment in Q 5.4

To do justice and act righteousness in favorable atmosphere is meritorious enough but the most different one is real test comes when one has an aversion, only very few people do xxvi

this and overlook the past and deal with the situation righteously. In Islam nothing less is required failing to do this would certainly make one swerve? to the wrong and depart from justice. Being just is next to prety fearing God should therefore be one guiding principles (motto) knowing that Gid is well acquinted with all our deeds. knowing that God is well as acquinted with it (M.salaudeen, 1990).

2.5.6. Goodness to parents

In the holy Quran, it is stated as follows

Q 17; 22-23

For your Lord has decreed that you worship none but Him. And honour your parents. If one or both of them reach old age in your care, never say to them 'even' 'ugh,' nor yell at them. Rather, address them respectfully.

The lord has decreed that you worship them but Him and to be kind to your parents whether one or the both attain old age in life say not to them but in terms of honour and out of kindness lower to them the Qing of humility; and say my lord bestow on to them the mercy as they cherishes me in my childhood

In this beautiful expression, we know that it is forbidden to worship anything or anybody. None is worthy of worship than Him. He is our creator and he feed us. Do not associate anything with Him in any way and in any condition. He is perfect in knowledge he ordered us to worship none but Him and to be kind to our parents as being next to the worship of Allah. Almighty Allah emphasize kindness to parents it is narrated in Hadith thus "paradise is under the feet of our mother" this means one who disregard his mother may not enter paradise. Generally speaking it is both parents that deserve our adequate caring

Prophet Muhammad (PBUH) says

The hanger of Almighty started from the end hanger of your parents and the peace is from them too. Although one is instructed to be kind to parents and heed their adoised but put Allah first (Salaudeen, 1990)

2.5.7 Hoarding of Goods

Men and women are allowed to engaged in lawful trade in the shariah, in the Hadith, men and women are mentioned as selling to aid buying from one another hoarding any food items is unlawful it is through this human practice that the society suffers a lot. The castle seller is prohibited from leaving unlimited for some days before selling. So that they may fetch higher price. This is more deceptive, fruit and crops must be in a fit condition because it may give rise to dispute. The fruits or crops in tree can only be sold if they are properly valued. The imagery sales of things, when they are not good to deliver are totally prohibited. Allah says

2.5.8 Moderation in Spending

Extravagance means spending money wastefully. It is often found together with pride and arrogance because spending money is reckless and conspicuous manner is a way of drawing people attention and making them marvel at ones wealth. The Quran states

Allah says Q2 v 188


And do not consume one another wealth unjustly or said it in bribery to the rules in order that they might aid you consume a portion of the wealth of the people in sin while you know it is unlawful

It was agreed by (100%) of the total respondents while none disagreed with it

Islamic studies is the only tools equipment to at can solve the problems of indiscipline. It was agreed by (60%) of the total respondents while (40%) disagreed with it. Inculcation of adequate discipline will help Muslim students to behave well. It was agreed by (85%) of the total respondents while (25%) disagreed with it.

This project research is focused on indiscipline in higher institutions of learning among Muslim students and Islamic antidote. The researcher highlighted the e motivation behind the choice of the topic of study. It also gives statement of problems, formulated hypothesis and research question on these problems.

5.4 Recommendations
